National Research Program for Universities (NRPU)

Introduction

NRPU is a flagship Research Program of HEC for funding research grants on competitive merit for highquality and promising scientific research projects that demonstrate strategic relevance and cast impact to the local industry and society. The program is open for contributions related to both basic and applied research.

Area of Research

- **Discipline** NRPU for all Disciplines.
- Objectives

NRPU aims to stimulate scientific excellence and the advancement of knowledge by allowing researchers the freedom to formulate by themselves the research concept and method.

• Domain/Theme

Arts & Humanities, Economic & Social Research, Engineering & Physical Sciences, Medical Sciences, Biotechnology & Biological Sciences, Natural & Environmental Sciences, Science & Technology.

Criteria

• Principle Investigator must be faculty member (PhD or FCPS/MCPS/FRCS) working in HEC universities and can hold only one NRPU grant at a time.

Funding Amount

Budgets for NRPU awards range up to Rs. 20 Million, with a maximum project duration of 3 years.

Deadlines

For 2021, last date of submission of proposal was 07th May, 2021. (Deadline date varies)

Interim placement of Fresh PhDs (IPFP)

Introduction

The IPFP (Interim Placement of Fresh PhDs Program) was launched in 2009by HEC with the objective of providing employment to selected fresh PhDs for one year as Assistant Professor against vacant TTS (Tenure Track System) positions in public or private universities.

Area of Placements/Research

- **Discipline** NRPU for all Disciplines.
- **Objectives** The objective of the program is to assist fresh PhD graduates in acquiring the skills and exposure needed to enter the academic job market.
- **Domain/Theme** IPFP is for open for all disciplines as per the requirements.

Criteria

Individuals who are native of Pakistan/AJK having degree of PhD with two research papers published in HEC recognized/indexed journals, not more than age of 40 at the time of advertisement are eligible to apply.

Pay/Funding Amount

HEC will pay a fixed Salary/Remuneration, currently fixed at PKR 100,000/- per month for a period of 12 months from the date of joining to the IPFP Fellows.

International Research Support Initiative program (IRSIP)

Introduction

Higher Education Commission of Pakistan is offering a six-month research fellowship abroad to those students who are enrolled in full time PhD programs in Pakistan. This is providing exposure to the PhD scholars which will enhance the quality of research that they will be conducting in Pakistan.

Area of Research/Fellowship

For all disciplines which includes Agriculture & Veterinary Sciences, Biological & Medical Sciences, Physical Sciences, Engineering & Technology, Management Sciences and Social Sciences.

Objectives

Pakistan Program for Collaborative Research (PPCR)

Introduction

Pakistan Programme for Collaborative Research allows for university faculty working in Pakistan to go abroad or for researchers from technological advanced countries to come to Pakistan. Preference is given to faculty members visiting foreign institutions that have recognized excellence in the relevant research area.

Area of Research

PPCR is for all disciplinary research.

Objectives

The main aim of this funding, which is open to all fields of research, is to initiate or to consolidate international collaborations. To reach this aim, short research activity between the host institution and the visiting fellow should be carried out during the stay.

Criteria

Faculty members in HEC recognized universities with 3 years Post-PhD experience and having good publications record are eligible to apply.

Funding Amount

Maximum allowance is US\$2000 per month with return airfare is Rs 1,85000.

Durations

Minimum 4 weeks to maximum 4 months as per the nature of the program.

Introduction

HEC is concentrating on promoting research culture in social sciences. It intends to encourage the creative and talented faculty members to probe into those areas that check the growth, development and progress of Pakistan. Thematic research program in social sciences aims to discourage the on-going brain drain and utilizing the innovative thinking of researchers.

Area of Research

Thematic Research Grant Program is for Social and Behavioral Sciences.

Objectives

This program aims to Identify all those possible avenues which can ensure the concept of innovation and commercialization of research output. It also aims to ensure continuity, implementation, and institutionalization of previous research done under Thematic Research Grant Program.

Criteria

Faculty members having PhD and MPhil/MS degrees are eligible to apply. All faculty members of government universities and 28 private universities (mentioned in the website) are eligible for public-private partnerships as per this program.

Funding Amount

Maximum funding would be up to Rs. 10.0 million for each research project.

Duration

Grants will be awarded for one year.

Upgradation of Labs Program

Introduction

HEC aimed to strengthen and up-grade the existing Laboratories and Libraries of recognized public sector Universities/Degree Awarding Institutions and recognized campuses.

Area of Research (Fund Awarding Domains)

Grant will be used for the purchase of small to medium sized scientific equipment, library material like chemicals, glass wares, oscilloscope, telescope, electrometer, Photostat machine, Scanner and other research equipment/items.

Objectives

The objective of this program is to support higher education institutions by giving grants of maximum 3.00 Million to upgrade their existing laboratories and libraries in order to conduct research work in different fields.

Criteria

Applicants (PI) should be regular/TTS basis faculty members in universities of Pakistan. All universities within Pakistan are eligible to apply. All proposals will be submitted through online system.

Funding Amount

Maximum funding would be up to Rs. 3 million.

Duration

Grants will be awarded whenever items, equipment and other research materials are needed to respective universities.

Post-Doctoral Fellowship Program

Introduction

The project offers 1000 fellowships over a span of 5 years. These fellowships are offered on open merit at the national level. Seventy percent slots are reserved for faculty members of public sector universities and institutes, private universities are given 15 percent slots and 15 percent of these slots are kept for public sector R&D organizations (recognized by Pakistan Council of Science and Technology).

Area of Research/Domains

Post-Doctoral Fellowship program is for all disciplines.

Objective

To provide an opportunity to work in well-equipped research laboratories of the world and to work in new/ emerging fields. To develop further foreign linkages through placement of PhD students and other researchers at the host institution.

Criteria

Hold PhD degree from HEC recognized university and be a regular employee of public/private sector HEC recognized university/degree awarding institution or public sector R&D organization.

Funding Amount

The maximum fellowship amount per scholar for total duration of scholarship (including living allowance, Health Insurance, Research/Lab cost and Air Ticket).

Partial Support Program

Introduction

The Higher Education Commission has instituted a special financial scheme to provide relief to students of the final stages of doctoral studies. Through this scheme, monetary support can be provided to overseas scholars who require partial assistance in the final stages of their doctoral studies. This applies to PhD students who need this support to complete their programs.

Area of Research

Partial Support Program is for all the programs/disciplines of doctoral studies.

Objectives

This program aims to provide a safety net to students and faculty members studying abroad for their PhD.

Criteria

This applies to PhD students.

Funding Amount

Under the Partial Support for PhD Program, HEC will grant successful applicants a one-time award with a maximum amount of US \$15,000. The amount can cover tuition fee, research or study related expenses, or living allowances.

Duration

The program is open for applications the entire year. Meetings are held every quarter for the selection of individuals who will receive the award. This award is for the last year of PhD studies.

Objectives

This program aims to promote academic writing skills, get intellectual input from writers on national issues, to provide a platform for writers to explore and share their ideas and information.

Criteria

This scheme is open for researchers and faculty members from HEC recognized public, private universities and R&D organizations across the country.

Funding Amount

HEC provides maximum amount of Rs. 1 lac. However, amount varies as the per the nature of write-up and publications.

This program is open when HEC needs to advertise it. Upon advertisement applicants need to submit their respective write-up data within given deadlines.

HEC Research Travel Grant

Introduction

HEC has set up a special Research Travel Grant Fund for University faculty, PhD scholars, and MS students at Pakistani Universities. Under this program, an academician or student selected to present research work at a national or international academic event is eligible to get funding from his/her academic institution and the academic institute will ultimately seek funding from HEC by applying for reimbursement.

Area of Research

For the research work of all disciplines/programs.

Objectives

This program aims to extend financial assistance to faculty and researchers to present their research work at national and international events and to share academic and research experiences and achievements at national as well as international level.

Criteria

The principal author (could be either first or the corresponding author who are citizen of Pakistan) of the presented paper will be eligible.

Funding Amount

HEC provides funds as per the nature of conference/event. Details are

• International Travel:

Airfare (as per HEC policy), Registration Fee (up to a maximum of USD 500), Accommodation (up to \$100 per night) as per number of days of the conference+1 day, Daily Allowance (as per HEC policy.

• National Travel:

Conference fee, if applicable. TA/DA as admissible in Govt. rules as per number of days of the conference+1 day.

Procedure

In order to avail Travel Grant, applicants may apply to his/her respective University (public sector and eligible private sector) and the University will ultimately seek funding from HEC by applying for reimbursement. HEC will not entertain the applications directly under the said program.

Pakistan-US Science and Technology Cooperation Program

Introduction

This program is implemented by the National Academy of Sciences (NAS) in the U.S. and by the Higher Education Commission (HEC) in Pakistan. It is intended to increase the strength and breadth of cooperation and linkages between Pakistani scientists and institutions with counterparts in the United States.

Area of Research

This program aims to contribute in several disciplines like Education, Health, Nutrition, Water/sanitation, Agriculture, Democracy and governance, Technology transfer, Entrepreneurship, Innovation, and commercialization, Economic development, Social sciences and Environment & energy.

Objectives

Projects funded under this solicitation should contribute to building research capacity in Pakistan while strengthening U.S. - Pakistan cooperative relationships by enhancing the ability of the science and technology community to spur human and economic development in Pakistan. It also aims to improve the capacity of Pakistani research institutions to support industry competitiveness.

Criteria

Principal Investigator (PI) can submit the proposal as per the mentioned guidelines on the website. Proposals are to be developed by partnerships that should include at least one Pakistani partner and one U.S. partner. Pakistani partners must be based at a HEC-recognized public sector university or a HECrecognized private sector research funding eligible university. PI and Co-PI may submit one proposal at a time.

Funding Amount

Financial support will be provided as per the nature of the proposals/projects. The total budget of the project should not exceed more than \$500,000 for the life of the project. Pakistan Science Foundation(PSF) is the apex body for promotion and funding of scientific and technological research and science popularization in the country. The Foundation functions as a link of Pakistan Museum of Natural History (PMNH)/ Pakistan Scientific and Technological Information Center (PASTIC) agency for the establishment of comprehensive scientific and technological information dissemination centers, promotion of research in the universities and other institutions, establishment of science centers, museums, promotion of scientific societies, organization of periodical science conferences, exchange of visits of scientists with other countries, prizes and fellowships to individuals engaged in developing processes of consequence to the economy of the country.

1. Research Support Program

Area of Research

- Discipline
 - PSF for all Disciplines.
- Objectives

The Promotion of Scientific Research and related activities is the major objective of Pakistan Science Foundation, which provides funding for research projects in the areas of Agricultural Sciences, Biological Sciences, Bio-technology and Genetic Engineering, Chemical Sciences, Computer/Information Technology, Mathematical Sciences, Environmental Sciences, Engineering, Earth sciences, Medical sciences and Physics.

• Domain/Theme

Research projects funded by the Foundation produce trained manpower in the form of MPhil and PhD graduates and other staff appointed in the projects, patents and a number of local and international publications.

Criteria

Projects proposals, submitted to the Foundation, are evaluated initially by Subject Experts in the relevant fields and then by the PSF Technical Committees which recommend the projects for approval on the basis of technical merit and relevance to the socio-economic needs of the country.

Grants for the purchase of lab. equipment, chemicals, literature etc. to strengthen the research capabilities of these institutions in order to carryout R&D work.

Objectives

To support institutes for scientific research.

Criteria and Funding Amount

Those institutes who meet the criteria and in need of purchase of scientific materials are eligible for this grant program.

Duration and Deadline

Duration and Deadline varies.

3. PSF Research Support (Support to Scientific Societies)

Introduction

Pakistan Science Foundation provides grants-in-aid to these societies and learned bodies for holding of conferences and publication of scientific journals.

Area of Research

For conferences and publications of all disciplines.

Objectives

To promote publications and conferences culture within the research societies. **Criteria**

- Societies should be registered with Registrar Societies under the Societies Act XXI of 1860.
- They should have fairly good membership.
- They should have established credibility at national level.

Funding Amount

Maximum grant is 1 lac PKR.

Duration and Deadline

Funds allocate for one year.



4. Grants for Publications in Journal

Introduction

PSF funds to support research publications in selected journals of Pakistan.

Area of Funding

For all disciplines.

Objectives

To promote journals for valuable and significant research work publication.

Criteria

Only selected journals and those who meet the criteria of PSF are eligible for that grant.

Funding Amount

Maximum amount 1 lac PKR per journal.

Duration

This grant is provided once a year.

5. PSF Grants for Awards and Fellowships

Introduction

Awards and prizes are granted by PSF to individuals engaged in developing processes, products, invention/innovations in order to provide incentive for valuable scientific Research.

Awards Categories

- Awards for inventions/innovations.
- Awards for commendable achievements in PSF research projects.

Objective

Aim to promote valuable scientific research.

Criteria

Eligibility criteria for Fellowships:

- The Candidate must be enrolled for M.Phil/Ph.D. in a Public Sector University.
- He/She should have throughout 1st Division in his/her academic career.
- He/She should not have any other source of income.

Funding Amount

Maximum 13,000 PKR per month to carry out research work.



Duration and Deadline

Duration and deadline varies.

6. Grants to Science Conferences, Seminars and Workshops

Introduction

Global Environmental Facility (GEF)

Introduction

The Global Environment Facility was established on the eve of the Rio Earth Summit to tackle our planet's most pressing environmental problems. Since then, it has provided more than \$21.7 billion in grants and mobilized an additional \$119 billion in co-financing for more than 5,000 projects and programs. GEF funds are available to developing countries and countries with economies in transition to meet the objectives of the international environmental conventions and agreements.

Objectives

Provide adequate and sustainable financial resources to eligible Parties to assist in their implementation of the Stockholm Convention.

Project Types

- Full Sized Projects and Medium Sized Projects
- Enabling Activities
- Programmatic Approach
- Climate Change Adaptation Projects
- Small Grants Programme

Full Sized Projects and Medium Sized Projects

FSPs - **Over** \$1 million - Project concepts may be developed by governments, non-governmental organizations, communities, the private sector, or other civil society entities, and must respond to both national priorities and GEF focal area /LDCF/SCCF strategies and objectives, and must satisfy eligibility requirements under the Conventions.

MSPs - Up to US \$1 million - MSPs offer opportunities for a broad range of programming that is typically smaller in scale than full-sized projects and follow expedited procedures for their approval. Funding such projects increases GEF flexibility in allocating its resources and encourages a wide range of stakeholders to propose and develop project concepts. MSPs are limited to a maximum of \$1 million in GEF and SCCF funds and \$ 2 million in LDCF funds.

Enabling Activities

The GEF finances Enabling Activities related to the conventions on biodiversity, climate change, and persistent organic pollutants, to help countries prepare national inventories, strategies, action plans, and reports under these conventions.

Programmatic Approach

A program usually contains several projects that are linked through common objective/s of the program aimed to foster increased horizontal and vertical integration of global environmental issues into the country(ies) development agenda.



Climate Change Adaptation Projects

Projects that fall under the area of Adaptation of the Climate Change focal area can apply for funds available:

- 1. Special Climate Change Fund (SCCF)
- 2. Least Developed Countries Fund (LDCF)
- 3. Adaptation Fund

Small Grants Programme

The Program is specifically designed to mobilize bottom-up actions by empowering local civil society organizations, and poor and vulnerable communities, including women and Indigenous Peoples. The Programme funds grants up to a maximum of \$50,000. In practice, the average grant has been around \$25,000. The program is about biological diversity and climate change.

Eligibility Criteria

Any eligible individual or group may propose a project. However, to be taken into consideration, a project proposal has to fulfill the following criteria:

- It is undertaken in an eligible country. It is consistent with national priorities and programs.
- It addresses one or more of the GEF Focal Areas, improving the global environment or advance the prospect of reducing risks to it.
- It is consistent with the GEF operational strategy.
- It seeks GEF financing only for the agreed-on incremental costs on measures to achieve global environmental benefits
- It involves the public in project design and implementation.
- It is endorsed by the government(s) of the country/ies in which it will be implemented
